- 1. <u>MINUTES OF MEETING</u> On a motion of Renee Ortiz, seconded by Steven Raccuglia, the minutes of the Board of Directors meeting held October 8, 2015 were approved by all without change.
- 2. <u>AUTHORIZATION TO ENTER INTO A SUBRECIPIENT AGREEMENT WITH</u> <u>FAMILY SERVICE LEAGUE, INC.</u> – On a motion of Ramon Colon, seconded by Renee Ortiz, and approved by all, authorization was granted for the Executive Director to enter into a sub-recipient agreement with Family Service League in the amount of \$80,000.00 under the 2015 Emergency Solutions Grant. The funds will be used for rapid re-housing and homelessness prevention.
- 3. <u>AUTHORIZATION TO ENTER INTO A SUBRECIPIENT AGREEMENT WITH</u> <u>L.I. AGAINST DOMESTIC VIOLENCE, INC.</u> – On a motion of Renee Ortiz, seconded by Steven Raccuglia, and approved by all, authorization was granted for the Executive Director to enter into a sub-recipient agreement with Suffolk Coalition against Domestic Violence in the amount of \$16,121.45 under the 2015 Emergency Solutions Grant. The Funds will be used for homelessness prevention.
- 4. <u>AUTHORIZATION TO ENTER INTO A SUBRECIPIENT AGREEMENT WITH</u> <u>OPTIONS FOR COMMUNITY LIVING, INC.</u> – On a motion of Steven Raccuglia, seconded by Ramon Colon, and approved by all, authorization was granted for the Executive Director to enter into a sub-recipient agreement with Options for Community Living in the amount of \$34,039.00 under the 2015 Emergency Solutions Grant. The funds will be used for rapid re-housing and homelessness prevention.
- 5. <u>AUTHORIZATION TO ENTER INTO PROFESSIONAL SERVICE CONTRACT</u> On a motion of Manuel Troche, seconded by Renee Ortiz and approved by all, authorization was granted for the Executive Director to enter into a two year professional services contract with Graham Associates, being the lowest responsible bidder, for the design and specification of renovations to CDA owned houses under Direct Sale and rent with Option to Buy Affordable Housing Programs. The contract with be for a fixed fee of \$4,666.66 per house. It is estimated that these services will be required for approximately ten houses in the next twenty-four months. (see attached)
